ARRESTED PERSON GRAHAM WEST, ANGELA WAS INTOXICATED WHILE OPERATING A VEHICLE DUE TO THE INTRODUCTION OF ALCOHOL INTO HER BODY AND DID NOT HAVE THE NORMAL USE OF HER MENTAL AND PHYSICAL FACULTIES WHILE OPERATING A MOTOR VEHICLE IN A PUBLIC PLACE AND ALSO WHILE THE VEHICLE WAS BEING OPERATED BY THE ARRESTED PERSON GRAHAM WEST, ANGELA, AN INFANT CHILD PASSENGER THAT WAS 3 MONTHS OF AGE WAS INSIDE OF THE VEHICLE AT 10200 SHADY TRAIL DALLAS, DALLAS COUNTY, TEXAS.

ON 08/20/2021 AT ABOUT 8:44 P.M. ARRESTING OFFICER (AO) L. HARRIS #11792 OBSERVED A WHITE SUV TYPE MERCEDES BENZ TRAVELING WESTBOUND AT THE 2700 BLOCK OF WEST NORTHWEST HIGHWAY (HWY). SCENERY: IT WAS DARK OUTSIDE WITH STREET LIGHTING ASSISTING WITH ILLUMINATION, ALSO THE ROAD WAS DRY AND THERE WAS NO RAIN. AO L. HARRIS #11792 OBSERVED THE WHITE SUV TYPE MERCEDES WAS BEARING TEXAS TAG# NTS2238. AO L. HARRIS #11792 OBSERVED THAT THE WHITE MERCEDES BENZ FAILED TO SIGNAL WHILE CHANGING LANES. THE WHITE MERCEDES BENZ CHANGED LANES AND ENTERED INTO THE RIGHT LANE.

AO L. HARRIS #11792 OBSERVED THE WHITE SUV TYPE MERCEDES ENTER ONTO THE SHOULDER AND TRAVELED IN BETWEEN THE SHOULDER AND THE RIGHT LANE. THE WHITE SUV TYPE MERCEDES WAS STRADDLING THE RIGHT LANE AND THE SHOULDER. THE WHITE SUV TYPE MERCEDES CONTINUED TO TRAVEL WESTBOUND ON W NORTHWEST HIGHWAY WHILE GETTING FURTHER AND FURTHER ONTO THE SHOULDER. HARRIS #11792 APPROACHED THE VEHICLE AND SMELLED THE SCENT OF ALCOHOL COMING FROM WITHIN THE CAR. AO L. HARRIS #11792 ALSO OBSERVED ARRESTED PERSON GRAHAM WEST'S WHITES OF HER EYES TO BE BLOODSHOT RED. AO L. HARRIS #11792 ALSO OBSERVED THAT THERE WAS AN INFANT CHILD THAT WAS IN A CAR SEAT IN THE BACK RIGHT SEAT OF THE VEHICLE. AO L.
